Update on Rules and Guidelines

DC OP3's draft Rules and Guidelines and Procedures were published for public comment on April 29, 2016. The Rules outline the process for the development, solicitation, evaluation, award, delivery, over sight of solicited and unsolicited P3 projects in the District. A more user-friendly version of the Rules with additional non-binding guidance is provided in the Guidelines and Procedures.

The 30-day comment period for the draft Rules and Guidelines closed on May 30, 2016. OP3 appreciates of all of the helpful feedback that was provided, <u>which is available on OP3's</u> <u>website</u>, and will strengthen our procurement process and procedures. OP3 intends to publish revised versions of the documents that incorporate many of the ideas submitted to OP3. The Rules will also be submitted for review by the D.C. Council before they take effect.
