#### **OP3 Rules Approved by Council**

We are pleased to report that, after a recent hearing (<u>watch the video here</u>), the DC Council has approved our procurement rules. Thank you to those who shared their feedback and supported us in this process. The rules and guidelines will take effect upon publication in the D.C. Register, which will occur in the coming weeks. We can then launch projects through a solicited process and will be open to accept unsolicited proposals after a 30-day period during which we encourage potential proposers to meet with us first. Stay tuned for more updates on these critical next steps!
