Rules and Guidelines Available for Public Comment

Today, DC OP3's draft Rules and Guidelines and Procedures were released for public comment. The Rules outline the process for the development, solicitation, evaluation, award, delivery, and oversight of solicited and unsolicited P3 projects in the District. A more user-friendly version of the Rules with additional non-binding guidance is provided in the Guidelines and Procedures. We encourage everyone to review both documents during the 30-day comment period and share your ideas with us via drafts.dc.gov, an innovative, open-source tool that allows for collaborative discussion.
